compare it to your actual, which couldn't do with our old system - we had to use spreadsheets.

"A big advantage with Xero is that you can upload all your suppliers invoices. If we were trying to look back on something under the old package we'd have to go and dig out the hard copy. With Xero you can just click on the purchase invoice and it is saved online, so that makes a massive difference.

"We are confident with our accounts information. Xero makes it easy to process information directly to HMRC, meeting the Making Tax Digital requirements.
